

House Bill 255 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the composition and election of the Board of Education of
2 Emanuel County, approved April 12, 1982 (Ga. L. 1982, p. 4049), as amended, particularly
3 by an Act approved February 27, 2012 (Ga. L. 2012, p. 3741), so as to change the description
4 of the education districts; to provide for definitions and inclusions; to provide for
5 continuation in office of current members; to provide for election and terms of office of
6 subsequent members; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the composition and election of the Board of Education of Emanuel
10 County, approved April 12, 1982 (Ga. L. 1982, p. 4049), as amended, particularly by an Act
11 approved February 27, 2012 (Ga. L. 2012, p. 3741), is amended by revising Section 1 as
12 follows:

13 "SECTION 1.

14 (a) The Board of Education of Emanuel County shall consist of seven members, all of
15 whom shall be elected from education districts described in subsection (b) of this section.

16 (b) For purposes of electing members of the board of education, the Emanuel County
17 School District is divided into seven education districts. The seven education districts shall
18 be and correspond to those seven numbered districts described in and attached to and made
19 a part of this Act and further identified as 'Plan: emansb-court-p1-2016 Plan Type: Local
20 Administrator: Emanuel SB User: Gina'.

21 (c)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
22 mean and describe the same geographical boundaries as provided in the report of the
23 Bureau of the Census for the United States decennial census of 2010 for the State of
24 Georgia.

25 (2) The separate numeric designations in a district description which are underneath a
 26 VTD heading shall mean and describe individual Blocks within a VTD as provided in the
 27 report of the Bureau of the Census for the United States decennial census of 2010 for the
 28 State of Georgia.

29 (3) Any part of the Emanuel County School District which is not included in any such
 30 district described in that attachment shall be included within that district contiguous to
 31 such part which contains the least population according to the United States decennial
 32 census of 2010 for the State of Georgia.

33 (4) Any part of the Emanuel County School District which is described in that
 34 attachment as being in a particular district shall nevertheless not be included within such
 35 district if such part is not contiguous to such district. Such noncontiguous part shall
 36 instead be included within that district contiguous to such part which contains the least
 37 population according to the United States decennial census of 2010 for the State of
 38 Georgia.

39 (5) Except as otherwise provided in the description of any education district, whenever
 40 the description of such district refers to a named city, it shall mean the geographical
 41 boundaries of that city as shown on the census map for the United States decennial census
 42 of 2010 for the State of Georgia."

43 **SECTION 2.**

44 Said Act is further amended by striking the redistricting plan at the end of such Act and
 45 inserting in lieu thereof the following:

SECTION 3.

219 (a) All members of the board of education serving in office on the effective date of this Act
 220 shall continue to serve until the expiration of the terms for which they were elected and until
 221 their respective successors are elected and qualified unless otherwise removed from office
 222 as provided by the Constitution and laws of this state.

223 (b) Each member of the board of education serving in office on the effective date of this Act
 224 and elected from former Education District 1, 2, 3, 4, 5, 6, or 7 shall on and after said date
 225 be deemed to represent the new Education District 1, 2, 3, 4, 5, 6, or 7 in which he or she
 226 resides.

227

SECTION 4.

228 All laws and parts of laws in conflict with this Act are repealed.
