A BILL TO BE ENTITLED AN ACT

1 To amend Subpart 1 of Part 3 of Article 7 of Chapter 3 of Title 20 of the Official Code of 2 Georgia Annotated, relating to general provisions regarding the Georgia Student Finance 3 Authority, so as to provide for voluntary donations through state income tax returns and 4 drivers' licenses for funding undergraduate tuition grants to children of law enforcement 5 officers, firefighters, paramedics, emergency medical technicians, prison guards, and Highway Emergency Response Operators of the Department of Transportation who were 6 7 disabled or killed in the line of duty; to provide for a short title; to provide for related 8 matters; to repeal conflicting laws; and for other purposes. 9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA: 10 **SECTION 1.** 11 This Act shall be known and may be cited as the "Shawn Smiley Act." 12 **SECTION 2.** 13 Subpart 1 of Part 3 of Article 7 of Chapter 3 of Title 20 of the Official Code of Georgia 14 Annotated, relating to general provisions regarding the Georgia Student Finance Authority, 15 is amended by adding a new Code section to read as follows: 16 "<u>20-3-316.2.</u> 17 (a)(1) Each Georgia income tax return form for taxable years beginning on or after 18 January 1, 2017, shall contain appropriate language, to be determined by the state revenue 19 commissioner, offering the taxpayer the opportunity to make a charitable contribution to 20 the Georgia Student Finance Authority to provide financial assistance toward the 21 postsecondary educational costs of the children of law enforcement officers, firefighters, 22 paramedics, emergency medical technicians, and prison guards employed by the state or 23 other public employer, and Highway Emergency Response Operators of the Department 24 of Transportation who were permanently disabled or killed in the line of duty by either 25 donating all or any part of any tax refund due and authorizing a reduction in the refund

26 check otherwise payable or contributing any amount over and above any amount of tax 27 owed by adding that amount to the taxpayer's payment. The instructions accompanying 28 the income tax return shall include a description of the intended use of the moneys 29 received from the contributions. Each taxpayer required to file a state income tax return 30 who desires to make a charitable contribution to the Georgia Student Finance Authority 31 may designate such contribution as provided on the appropriate income tax return form. 32 (2) The Department of Revenue shall determine annually the total amount so contributed 33 and shall transmit such amount to the Georgia Student Finance Authority.

34 (b) Beginning January 1, 2017, the Department of Driver Services shall, through 35 appropriate language on its forms for the issuance and renewal of drivers' licenses and 36 identification cards, offer individuals the opportunity to make a voluntary charitable 37 contribution of \$1.00, \$5.00, or \$10.00 to the Georgia Student Finance Authority to provide 38 financial assistance toward the postsecondary educational costs of the children of law 39 enforcement officers, firefighters, paramedics, emergency medical technicians, and prison 40 guards employed by the state or other public employer, and Highway Emergency Response 41 Operators of the Department of Transportation who were permanently disabled or killed in the line of duty. The form shall contain a description of the intended use of moneys 42 43 received from the contributions. Each individual who desires to make a charitable 44 contribution may designate such contribution on the appropriate form, and the Department of Driver Services shall accept such contribution. The Department of Driver Services shall 45 46 determine annually the total amount so contributed, shall withhold therefrom a reasonable 47 amount for administering this voluntary charitable contribution program, and shall transmit 48 the balance to the Georgia Student Finance Authority for funding, in whole or in part, the postsecondary educational costs of such students. If, in any tax year, the administrative 49 50 costs of the Department of Driver Services for collecting charitable contributions pursuant 51 to this subsection exceed the sum of such contributions, the administrative costs which the Department of Driver Services is authorized to withhold from such contributions shall not 52 exceed the sum of such contributions." 53
