A BILL TO BE ENTITLED AN ACT

To amend Article 13 of Chapter 6 of Title 40 of the Official Code of Georgia Annotated, relating to special provisions for certain vehicles with regard to uniform rules of the road, so as to permit the operation of certain vehicles on roads when used for agricultural or silvicultural purposes; to provide for restrictions and limitations; to provide for local restrictions; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.
8 Article 13 of Chapter 6 of Title 40 of the Official Code of Georgia Annotated, relating to
9 special provisions for certain vehicles with regard to uniform rules of the road, is amended
10 by adding a new part to read as follows:

"<u>Part 1A</u>

12 <u>40-6-305.</u>

- 13 (a) As used in this part, the term:
- 14 (1) 'Farmer' means the owner of a commercial agricultural or silvicultural operation or
- 15 <u>an employee thereof.</u> Such term shall also include any spouse, child, sibling, parent,
- 16 grandparent, or grandchild of the owner of such operation.
- 17 (2) 'Farm use vehicle' means an all-terrain vehicle or personal transportation vehicle.
- 18 (b) A farmer who is 16 years of age or older may operate a farm use vehicle on any public
- 19 road or highway of this state so long as:
- 20 (1) Such vehicle has a properly affixed emblem conforming to the requirements of Code
 21 Section 40-8-4; and
- 22 (2) Such vehicle is actively being operated by such farmer to transport:
- 23 (A) Agricultural products, livestock, farm machinery, or farm supplies to or from a

- (B) Such farmer between his or her residence and the farm at which he or she works
 or between properties of such farm.
- <u>40-6-306.</u>
- 28 Every person operating a farm use vehicle shall be granted all of the rights and shall be
- 29 <u>subject to all of the duties applicable to the driver of any other vehicle under this chapter</u>
- 30 except as to special regulations in this part and except as to the provisions of this chapter
- 31 which by their nature can have no application.
- 32 <u>40-6-307.</u>
- 33 <u>Any municipality may prohibit or limit the operation of farm use vehicles on public roads</u>
- 34 and highways within its jurisdiction if it is determined that such operation endangers the
- 35 <u>safety of the traveling public.</u>"
